**1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT**

Councillor Nakagawa opened the meeting at 9 a.m., and recognized with respect that New Westminster is on the unceded and unsurrendered land of the Halkomelem speaking peoples. She recognized that, as a City, we are learning and building relationships with the people whose lands we are on.

**4. REPORTS AND PRESENTATIONS**

#### **4.1 Checking the Pulse: Diversity, Inclusion, Equity and Anti-Racism Update**

John Stark, Supervisor of Community Planning, introduced Jasmindra Jawanda, Urban/Social/Cultural Planner, noting that this plan is more outward facing than the Diversity, Inclusion, Equity and Anti-Racism (DEIAR) framework that the City is pursuing internally.

Ms. Jawanda provided a presentation on the New Westminster Spokes Committee Anti-Racism project and detailed the steps of Phase II of the project.

In discussion, members noted this is important work, and that more development of opportunities and motions needs to occur. In response, Mr. Stark advised that staff and consultants can investigate collaboration and sharing best practices in the form of anti-racism.

#### **4.2 Woodlands Wall: Interpretation Panels and Heritage Plaque**

Britney Dack, Senior Heritage Planner, introduced the proposal for interpretive panels and a heritage plaque for the heritage wall alteration at McBride Boulevard and East Columbia Street.

Max von Kleist, Fraser Crossing Partners, and Phoebe Cheung, TI Corp, provided a presentation on the proposal.

In discussion, members provided the following comments:

- The Task Force's role should be minimal, and the focus should be on the lived experiences of Woodlands survivors;
- Suggested reaching out to participants from previous engagement sessions and Kinsight Community Society which may be able to help with connections;
- Support for the separation of the panels from the plaque; this differentiates lived experiences from the architectural importance of the wall and buildings; and,
- The longer term history and Indigenous peoples' piece is important as well, and should be considered for inclusion;
- Working groups should be empowered to be the leaders in creation and doing the content development;

- This could be bridged over to the Indigenous consultation for the overall bridge replacement project;
- Suggested to investigate Michael de Courcy's website which may help determine any graves on the site;

In response, Mr. Von Kleist, Ms. Cheung, and Steve Line, VIA Architecture provided the following information:

- They will circle back to the groups mentioned for more engagement;
- They are working with Inclusion BC and Community Living, and taking cues from these groups and individuals to ensure the process is fair and respectful; and,
- Designers are thinking about going beyond panels to tell stories with art and elements integrated with pavements and furnishings onsite.

The Task Force requested an update on engagement to ensure that the right people and groups are involved in engagement related to the Pattullo Bridge Replacement.

**Procedural Note:** Councillor Puchmayr left the meeting at 10:03 a.m. and did not return.

#### **4.3 Heritage Revitalization Agreement Policy Refresh: Diversity and Inclusion Principles**

Britney Dack, Senior Heritage Planner, provided a presentation on the Heritage Revitalization Agreement (HRA) refresh program for small-scale residential heritage developments, and requested feedback regarding diversity and inclusion principles.

In discussion, members provided the following information:

- Some of the pushback on HRA applications are because the housing being proposed is not affordable, which often seems like a red herring because infill housing is not generally considered affordable housing;
- Heritage is often interpreted in a narrow context and should include more intangible elements; and,
- There is a need to manage expectations.

In response, Ms. Dack provided the following information:

- Integrating more intangible heritage aspects is an important of the refresh program and she will be presenting to various committees and task forces, as well as community groups, for feedback and review;
- Any changes made through the refresh would not be applied to projects currently in the process; and,
- This program will not lead to deep discount affordability, but rather contribute to the housing continuum by providing more diversity in housing form options.

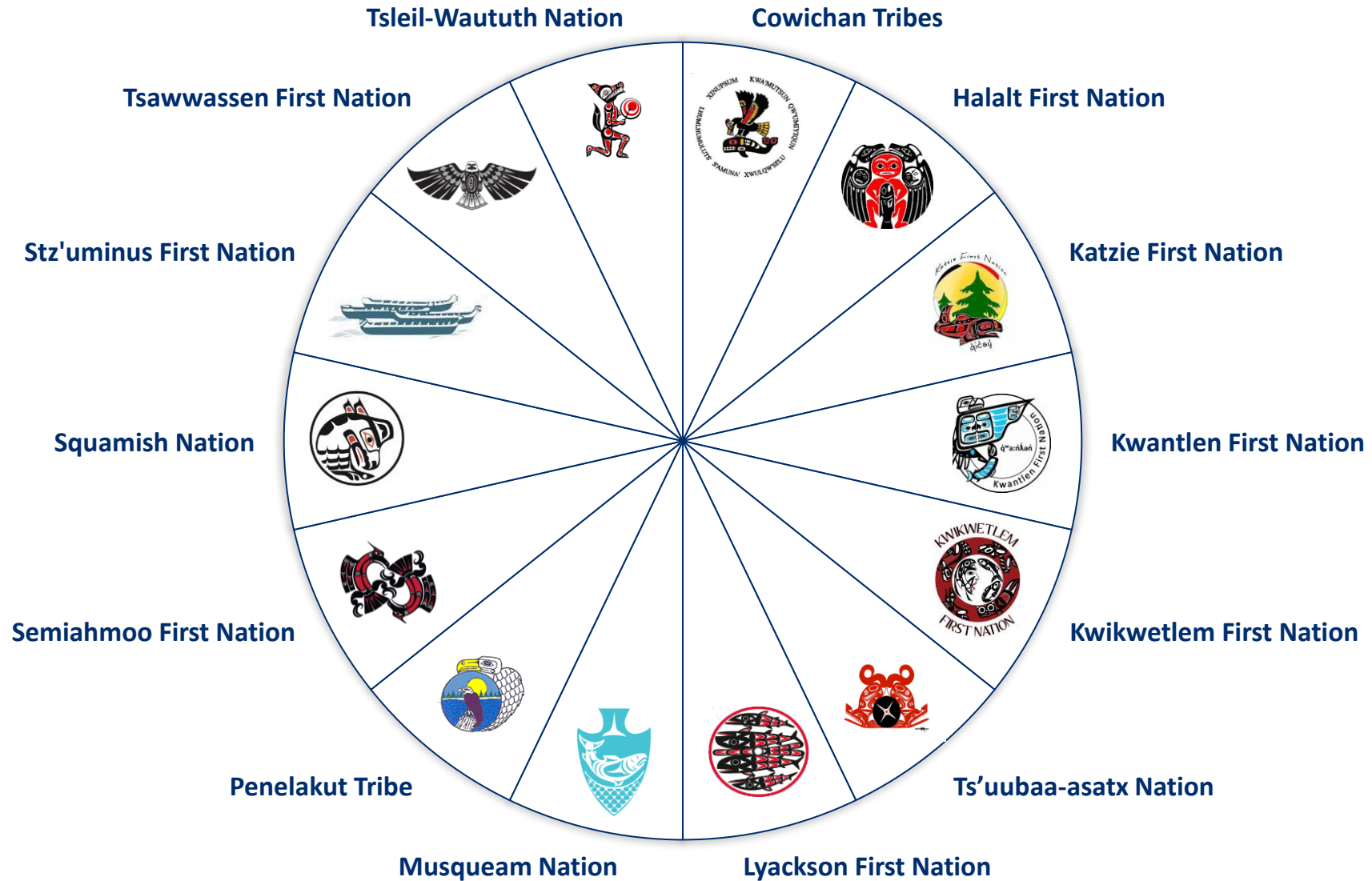
# Environmental Assessment Certificate

## Condition 16: Indigenous Cultural Recognition Plan

- Plan for Indigenous cultural recognition, interpretation, education and commemoration of heritage sites. Must be developed in consultation with Indigenous Groups and include:
  - Process for continued engagement with Indigenous groups
  - Description of how opportunities that have been requested by Indigenous groups have been considered
  - Process for Indigenous group involvement in implementation
  - Opportunities for Indigenous groups to review and comment on Project design

# Indigenous Art and Cultural Recognition Plan

## Vision

- Involve Indigenous Groups in the design and fabrication of cultural components
- Incorporate language and use green space and habitat areas to create an overall experience within an enhanced natural environment

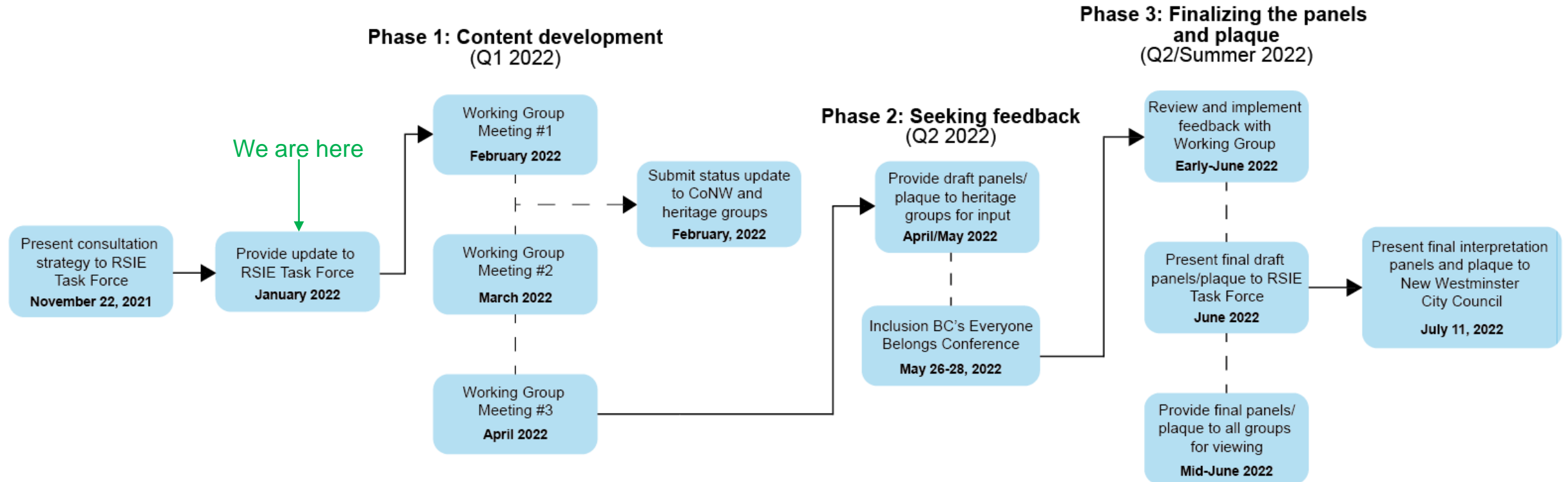
## Goals
