PURPOSE

To seek Council approval for the appointment of Council members to Resident Associations.

BACKGROUND

During the 2019 Council year, Council approved appointing individual Councillors as Council liaisons to each Residents Association. Councillors do not need to attend all meetings, but should attend meetings if invited to do so. Residents Associations may reach out to the Mayor’s office to coordinate the Mayor’s attendance at a meeting on a bi-annual frequency.

The Corporate Officer / City Clerk proposes a list for Council approval.

Legislative Services coordinates a meeting of Council with all the Presidents/ representatives of the Residents Association in the spring of each year.
