1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT

Mayor Johnstone opened the meeting at 6:00 p.m. and recognized with respect that New Westminster is on the unceded and unsurrendered land of the Halkomelem speaking peoples. He acknowledged that colonialism has made invisible their histories and connections to the land. He recognized that, as a City, we are learning and building relationships with the people whose lands we are on.

4. SPECIAL PRESENTATION

4.1 Year of Truth, 2023

Jen Arbo, Economic Development Coordinator, shared the story of residential school survivor Elder William and expressed anticipation of "A Year of Truth" continuing the efforts of Truth and Reconciliation in the City of New Westminster.

MOVED AND SECONDED

THAT Council receive the presentation regarding "A Year of Truth"; and

THAT Council direct Mayor Johnstone to proclaim March 2023 to March 2024 "A Year of Truth".

Carried.

All members present voted in favour of the motion.

Mayor Patrick Johnstone read aloud the proclamation and proclaimed March, 2023 to March, 2024 as A Year of Truth in the City of New Westminster.

5. REPORTS AND PRESENTATIONS FOR COUNCIL DISCUSSION AND ACTION

5.1 Extending School Zone Speed Limit Hours

During discussion, it was noted that analysis of the financial implications and road safety and policing concerns with respect to an extension of school zone speed limit hours will be presented to Council upon completion.

5.2 Outdoor Pool Extended Season Aquatics Plan

During discussion, it was noted that due to the limited capacity of the outdoor pool, the reservation system eliminates queues for the public.

The Scholarship Training Employment Program (STEP) is currently accepting applications for funding of the necessary training and will conditionally employ trained lifeguards and swim instructors.

THAT the March 13, 2023 report titled "2023 Outdoor Pool Extended Season Aquatics Plan" be received for information.

THAT Mayor and Clerk be authorized to execute the Amendment to extend the License to Occupy Agreement for the temporary use of a portion of BC Hydro property, substantially in the form included as Attachment "A" of the March 13, 2023 report titled Amendment to Extend License to Occupy BC Hydro Lands for Pollinator Meadow.

6.5 Site-Wide Liquor Licensing Program for Special Events

- Concern that reports specify changes that are in Council's purview;
- Concern that non-Business Improvement Association (BIA) events are encouraged; and
- Restaurant patios are permitted to open in alignment with the terms of their own license.

MOVED AND SECONDED

THAT Council directs staff to implement the Site-Wide Liquor Licensing Program using the proposed guidelines for Special Events; and,

THAT Council direct staff to seek feedback from businesses on the proposed Site-Wide Liquor Licensing for Special Events.

6.6 Urban Reforestation and Biodiversity Enhancement Initiative Update and Proposed Tree Planting at City Hall

During discussion, concern was noted regarding the extent of the community consultation undertaken with respect to alternate locations for the biodiversity enhancement initiative.

THAT the May 13, 2023 report titled "Urban Reforestation and Biodiversity Enhancement Update and Proposed Tree Planting at City Hall" be referred back to staff for a more detailed budget and opportunities for community consultation.

Defeated.

Mayor Johnstone and Councillors Henderson and Nakagawa opposed.

THAT Council receive this progress update on the Urban Reforestation and Biodiversity Enhancement Initiative; and

THAT Council approve planting of a full tree grove (Option A) on a portion of City Hall lands as outlined in the March 13, 2023 report titled Urban Reforestation and Biodiversity Enhancement Update and Proposed Tree Planting at City Hall.

Ashminder Gill, Results Canada, spoke to raise awareness on the impact of tuberculosis, marked by the World Health Organization as one of the world's worst infectious diseases which disproportionately affects Indigenous people and newcomers to Canada.

Mayor Patrick Johnstone read the proclamation and proclaimed March, 24, 2023 as World Tuberculosis Day in the City of New Westminster.

7. OPPORTUNITY FOR THE PUBLIC TO SPEAK TO COUNCIL - 7:00 PM

Elaine Su, New Westminster Public Library, provided information regarding the Seed Library launch event to promote climate activism.

Peijiang Miao, Resident, led the review of a presentation titled "Neighbours Support 22nd Station Master Plan" to support the continuation of the 22nd Street Station Master Plan to provide opportunities for improving the environment and attracting more residents to the Connaught Heights community.

Jag Sall, Sukh Sagar Gurdwara, highlighted the benefits of a sports facility in the Queensborough community to prevent isolation of seniors, support at-risk youth, and support a growing community.

Sukh Sidhu, Resident, expressed concerns for the health and wellness of the Queensborough community and commented on the benefits of a sports field and track in the community to promote physical exercise and mental health.

Sukh Sadhre, New Westminster Soccer Club, provided information regarding the growing Queensborough community and the need for facilities to support the growth. He expressed concerns regarding the decline in soccer registration, citing the barrier of access to fields and facilities.

Harpreet Bal, Queen Elizabeth Elementary School Parent Advisory Committee, raised concerns regarding the lack of outdoor spaces and suggested that a track would allow children to maintain activity levels.

Bernadette Gourlay, Queensborough Middle School Parent Advisory Committee, requested the construction of a full running track in Queensborough to support lifelong mental and physical health for its residents.

Mike Savage, Resident, spoke in support of increasing facilities for the Queensborough area.

- b. Ensuring the timely removal and replacement of dead and/or dying trees on city property

Submitted by Councillor Fontaine

Whereas it is a core function of our City to maintain a healthy stock of trees on public property and to have dead trees removed in a timely manner; and

Whereas a number of sidewalks, boulevards and areas in the public realm have dead or dying trees that have been there for at least one year; and

Whereas the City is committed to keeping all of our publicly-owned trees healthy and free of disease and/or vandalism; and

Whereas the City may be planting a significant number of new trees as part of our capital plan

BE IT RESOLVED that staff report back regarding the resources required and staffing implications to conduct an audit of how many

dead or dying trees are on city sidewalks, boulevards and adjacent to arterials that require replacement; and

BE IT FURTHER RESOLVED that the report incorporate the estimated costs associated with the removal of all dead and/or dying trees on city-owned land and have them replanted prior to the April 2024; and

BE IT FURTHER RESOLVED that upon approval of this resolution any tree on city-owned property which must be cut down to a stump will be removed and replanted within a 12 month period

c. Supporting Single Mothers' Alliance Transit for Teens Campaign

Submitted by Councillor Fontaine

Whereas for low-income youth whose families may not have access to a vehicle and the means to provide transit passes, and youth facing marginalization, transit access is a survival lifeline to access shelter, school, support services, health care, and food security; and

Whereas the cost of ensuring at-risk youth can access the essential programs and services funded to support youth outcomes in BC is downloaded onto non-profits that often struggle to 'remove the access barrier' of lack of access to transit; and

Whereas youth-in-need may miss the lifesaving supports available in BC due to mobility poverty and lack of access to transit is an avoidable travesty solved with free transit up to age 18; and

Whereas the City of New Westminster is committed to supporting our youth as well as issues which address equity, diversity and inclusivity

BE IT RESOLVED THAT the City of New Westminster endorse the Single Mothers' Alliance Transit for Teens Campaign; and in doing so, the Mayor write a letter to the Mayors' Council on Regional Transportation, the board of directors of BC Transit, the Ministry of Transportation and Infrastructure, the Ministry of the Environment and Climate Change Strategy, the Office of the Premier, the Ministry of Social Development and Poverty Reduction, the Ministry of Education and Child Care, the Minister of State for Infrastructure and Transit, the Ministry of Children and Family Development, and

the Select Standing Committee on Children and Youth to work with the provincial government to finalize and secure funding, and develop a plan that will provide free public transit for teens aged 13 to 18 in B.C.

THAT Council support the proposed UBCM motion, approve cosponsorship of the motion and direct staff to communicate this decision to LMLGA.
