## 3.1 Heritage Revitalization Agreement (802 and 806 Eighth Street and 809 Eighth Avenue) Bylaw No. 8379, 2023

Discussion ensued on:

- Underground parking is not required for smaller projects;
- The Official Community Plan (OCP) does not permit stacked townhouses at this location:
- The development construction plan governs the parking for construction vehicles;
- Parking spaces are not allocated for the accessible units; and,
- There is no designated permit parking at this location.

### 4. REPORTS AND PRESENTATIONS FOR COUNCIL DISCUSSION AND ACTION

### 4.1 Budget 2023: Draft 2023 - 2027 Financial Plan

Harji Varn, Chief Financial Officer and Director of Finance led the review of the presentation titled "2023 Draft Budget and 5-year Financial Plan", dated March 27, 2023, and highlighted:

- The focus of the budget is on maintaining financial health;
- The Five-Year Capital Plan totals \$410.6 million and includes:
  - General Fund of \$222.6 million
  - Utility Fund of \$187.9 million;
- The 2023 Multi-Year Capital Budget totals \$173.2 million;
- The draft 2023 Operating Budget includes estimated revenue of \$301.5 million, comprised of:
  - Municipal taxation (34.9%)
  - Utility Levies (36.7%)
  - Grant and contributions (15.8%)
  - Other Revenues (12.7%);
- The draft 2023 Operating Budget includes:
  - Approximately 20 new full-time equivalent (FTE) positions
  - One-time service enhancement increases of \$1.19 million;
- Proposed funding strategies include property tax revenue increase of 6.4%; and,
- The 2023 utility rate increase total 5.8%.

#### Discussion ensued on:

New construction tax revenue is attributed to growth; and,

• Council will deliberate and make recommendations regarding the Growing Communities Fund.

# 4. REPORTS AND PRESENTATIONS FOR COUNCIL DISCUSSION AND ACTION (CONTINUED)

## 4.1 Budget 2023: Draft 2023 - 2027 Financial Plan (Continued)

Discussion ensued on:

- Changes to WorkSafe BC policies have led to increased claims;
- Development cost charges (DCC) could increase and are dependent upon acceleration of growth;
- Climate Action Reserve Funds have not been allocated;
- The increase in parks and recreation expenses is due to the opening of the təməsewtxw Aquatic and Community Centre (TACC); and,
- Concern regarding the 6.4% property tax increase, costs at Queen's Park and rebranding costs.

#### MOVED and SECONDED

**THAT** Council instruct staff to convert the Draft Consolidated 2023 to 2027 Financial Plan into a Bylaw reflecting a property tax revenue increase of 6.4% for 2023 and a 2023 Capital Budget of \$173.2M and bring forward for three readings.

**Procedural Note:** As a result of the discussion, an amendment was introduced.

#### MOVED and SECONDED

**THAT** Council instruct staff to advise them prior to adoption of the first reading of the Draft Consolidated 2023 to 2027 Financial Plan bylaw what the impacts to the proposed tax increase would be if the following financial measures were implemented:

- Establish a \$1 budget for the City's rebranding process aimed at eliminating the Royal City moniker;
- Eliminate \$15,321,089 in funds earmarked for the installation of advanced "smart" meters;
- Eliminate \$46,337,399 in funding allocated for the District Energy Project in Sapperton;
- Eliminate \$509,897 funding for the Queen's Park Farm Transition plan which contemplates the installation of public infrastructure which includes items such as mushroom and insect walls;
- Allocate up to \$50,000 to remove "end of life" and non-functional structures from the former Queen's Park Petting Zoo and replace them with native tree species;
- Allocate up to \$400,000 to enhance the popular Queen's park children's play area to include new equipment that will encourage more physical literacy and active living;
- Reduce the Great Streets Program on 6<sup>th</sup> Street to \$2 million;
- Double the investment on bus shelters to \$100,000;
- Double the investment on bus stop improvements to enhance accessibility to \$160,000;
- Increase the pedestrian crossing improvements budget to \$2 million from \$1.2 million;
- Increase the whistle cessation infrastructure investment budget to \$2.5 million; and.
- Eliminate the \$2 million BridgeNet expenditure.

Defeated.

Mayor Johnstone and Councillors Campbell, Henderson, McEvoy, and Nakagawa opposed.

**Procedural Note**: The question on the main motion, as amended, was called.

**THAT** Council instruct staff to convert the Draft Consolidated 2023 to 2027 Financial Plan into a Bylaw reflecting a property tax revenue increase of 6.4% for 2023 and a 2023 Capital Budget of \$173.2M and bring forward for three readings.

Carried.

Councillors Fontaine and Minhas opposed.

The applicants, Kevin Shipalesky of The C&E Group, Andrew Rule of AECON Group Inc., and Keith Threadkell and Jason Warren of Metro Vancouver, noted:

- Noise mitigation measures are in place; and,
- The noise bylaw exemption is unlikely to be utilized and is a cautionary measure.

Discussion ensued on:

- Installation of onsite signage;
- Email notification will be provided to high impact audiences; and,
- Project update newsletters regarding construction and noise mitigation will be distributed.

#### MOVED AND SECONDED

**THAT** Council grant an exemption to Metro Vancouver contractor Traylor Aecon General Partnership (TAGP) from Construction Noise Bylaw No. 6063, 1992, from May 01, 2023 to September 30, 2023, and from January 01, 2024 to February 28, 2024 on weekdays from 8:00 p.m. to 11:00 p.m. and Saturdays from 7:00 a.m. to 9:00 a.m. and 6:00 p.m. to

9:00 p.m., excluding Sundays and Statutory Holidays, to construct the Annacis Water Supply Tunnel, Fraser River Crossing (the "Project").

**WHEREAS** the City is committed to keeping all of our publicly-owned trees healthy and free of disease and/or vandalism; and

**WHEREAS** the City may be planting a significant number of new trees as part of our capital plan.

**BE IT RESOLVED** that staff report back regarding the resources required and staffing implications to conduct an audit of how many dead or dying trees are on city sidewalks, boulevards and adjacent to arterials that require replacement; and

**BE IT FURTHER RESOLVED** that the report incorporate the estimated costs associated with the removal of all dead and/or dying trees on city-owned land and have them replanted prior to the April 2024; and

**BE IT FURTHER RESOLVED** that upon approval of this resolution any tree on city-owned property which must be cut down to a stump will be removed and replanted within a 12-month period.

Discussion ensued on:

- The City owns a stump grinding tool and will expedite the removal of stumps;
- The City has been tracking removal of trees since 2011; and,
- Approximately 400 stumps require removal.

## b. Preserving, Protecting and Enhancing the Samson V Museum for Future Generations

## **Submitted by Councillor Fontaine**

**WHEREAS** the Samson V museum is currently shrink wrapped on New Westminster's waterfront and has undergone major repairs over the past several years due to damage incurred as a result of a pesky pigeon problem;

**WHEREAS** the draft 5-year capital plan calls for significantly more tax dollars be invested in repairing and maintaining this civic museum which will continue to be severely impacted by outdoor weather conditions; and

**WHEREAS** this important part of our history deserves to be respected, kept in pristine condition and fully accessible to tourists, local citizens and students.

**BE IT RESOLVED THAT** staff report back on the costs, potential sources of funding and operational impacts associated with temporarily placing the Samson V in dry dock to repair and restore the vessel for public viewing;

**BE IT FURTHER RESOLVED** that staff report back on options to find a permanent indoor home for the Samson V adjacent to or on our waterfront as part of a possible pier expansion and/or long-term tourism strategy; and

**BE IT FURTHER RESOLVED** that staff consult with the Fraser River Discovery Center and other key stakeholders and report back regarding the opportunity and costs associated with undertaking a pilot program that would permit short-term pleasure craft usage at the moorage vacated by the Samson V.

# c. Hearing From the Communities Regarding Their Priorities for the new Growing Communities Fund

## **Submitted by Councillor Minhas**

**WHEREAS** the Government of British Columbia has provided the City of New Westminster with almost \$16 million as part of their Growing Communities Fund;

**WHEREAS** Council has an opportunity to engage with our citizens and listen to their feedback regarding what they think our priorities should be for this new investment.

**BE IT FURTHER RESOLVED** that staff develop an online survey opportunity for the public to provide their feedback regarding what priority areas Council should consider as part of the Growing Communities Funding.
