New Westminister Pesticide Use Amendment Bylaw No. 8403, 2023

**CORPORATION OF THE CITY OF NEW WESTMINSTER
BYLAW NO. 8403, 2023**

A Bylaw to Amend NEW WESTMINSTER PESTICIDE USE BYLAW, NO. 7288, 2008

The Council of The Corporation of the City of New Westminster in open meeting assembled ENACTS AS FOLLOWS:

Citation

1. This Bylaw may be cited for all purposes as “New Westminster Pesticide Use Amendment Bylaw No. 8403, 2023.”

Amendments

2. New Westminster Pesticide Use Bylaw 7288, 2008 is amended by:
 - a. Removing the definition for *accredited company* and replacing with:

accredited company means a landscaping company that holds a valid and appropriate licence issued under section 4 of the Integrated Pest Management Act.
 - b. Adding the following definition in Section 2 DEFINITIONS, in alphabetical order:

certified pesticide applicator means a person who maintains a valid and appropriate pesticide Applicator Certificate issued by the Province of British Columbia.
 - c. Replacing Section 4 (f) in its entirety with:

(f) the use of a *pesticide* to control an *infestation* only by *certified pesticide applicator* with an *accredited company*.
 - d. Replacing Section 8 in its entirety with:

Offences for which tickets can be issued and fines imposed are prescribed in Bylaw Notice Enforcement Bylaw No. 7318, 2009 and Municipal Ticket Information Bylaw No. 8077, 2019.
 - e. Deleting Schedule “A” and replacing it with the attached Schedule “A”

SCHEDULE "A"

PERMITTED PESTICIDES

The following substances are *permitted pesticides* and shall be excluded from the provisions of this Bylaw:

- (1) Acetic acid
- (2) Algicides and bactericides used in swimming pools, wading pools, whirlpools or ornamental fountains
- (3) Animal repellents, except thiram
- (4) *Bacillus* sp. (e.g. *Bacillus thuringiensis*)*
- (5) Borax, also called "boric acid"
- (6) Bordeaux mixture and other sulphur compounds
- (7) Corn gluten meal
- (8) Diatomaceous earth
- (9) Dormant Oils
- (10) Ferric phosphate
- (11) Horticultural Oils
- (12) Insecticidal soaps
- (13) Lime Sulphur
- (14) Other biological control organisms (e.g. nematodes)
- (15) Pheromone traps
- (16) Pruning paint
- (17) Pyrethrum

* In accordance with the *Integrated Pest Management Regulation*, residents may apply on their own private landscapes, including lawns, flower beds, ornamental trees and plants. A licence, issued by the Province, is required to offer a service applying this pesticide.
