Development Variance Permit for 300 Duncan Street, 313 to 325 Blackley Street, and 326 to 340 Mercer Street

Development Permit (DP000929) and Development Variance Permit (DVP00696) applications have been received to allow development of 146 residential townhouse units and 14 commercial units at 300 Duncan Street, 313 to 325 Blackley Street, and 326 to 340 Mercer Street. The applicant is requesting to reduce the required off-street visitor parking by 43% and permit 32% tandem parking (where two cars park front-to-back). The project would exceed Zoning Bylaw requirements for off-street resident parking (292 spaces) as well as long- and short-term bicycle parking.

This Development Variance Permit application will be considered for issuance on July 10, 2023. On July 12, 2021, Council approved a resolution requiring written feedback only on Development Variance Permit applications. 
