## 1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT

Mayor Johnstone opened the meeting at 6:00 p.m. and recognized with respect that New Westminster is on the unceded and unsurrendered land of the Halkomelem speaking peoples. He acknowledged that colonialism has made invisible their histories and connections to the land. He recognized that, as a City, we are learning and building relationships with the people whose lands we are on.

# 3. REPORTS AND PRESENTATIONS FOR COUNCIL DISCUSSION AND ACTION

# 3.1 Presentation of the 2022 Annual Report

#### a. Presentation (On Table)

Lisa Spitale, Chief Administrative Officer, led the review of a presentation titled "New Westminster Annual Report, 2022", and highlighted accomplishments.

Discussion ensued on:

- It is important to capture accomplishments, but the Annual Report could also include areas where the City can improve on what was not accomplished; and
- Construction of the new təməsewxxw public recreation center is ongoing and is expected to be finished early next year.

# b. Statement concerning the number of written submissions received, including On Table submissions (Corporate Officer)

Peter DeJong, Corporate Officer, advised that no written submissions had been received.

# c. Council consideration of the 2022 Annual Report

MOVED and SECONDED

**THAT** Council receive the 2022 Annual Report as presented.

Carried.

All members present voted in favour of the motion.

a. Presentation (On Table)

# b. Report: Council Code of Conduct Bylaw No. 8408, 2023

Reece Harding, Young Anderson, led the review of the presentation titled "City of New Westminster, Council Code of Conduct Bylaw".

Discussion ensued on:

- The importance of balancing punitive measures versus restorative measures, given that there are no financial penalties or reductions in remuneration;
- Some items in the proposed bylaw appear to be risky, where individuals might inadvertently contravene the Code if they do not follow specific disclosures to the public;
- Whistleblower protection will be forthcoming under a separate Council strategy, not to be included in the Code;
- The inclusion of culturally appropriate or transformative, restorative or Indigenous justice approaches is groundbreaking;
- The difficulty in recruiting an ethics commissioner in the Lower Mainland if Mayor and Council adopt the bylaw as presented; and
- The Code can benefit from adding language for extra protection to staff, due to a power imbalance between

elected officials and staff, and explicitly indicating that Mayor and Council can only go through the CAO for administrative requests.

Mayor and Council requested potential amendments to the Code:

- s.19 may be easy to inadvertently contravene and may be best suited to a policy, potentially also to define "minor" and "administrative clarity";
- s.25 is difficult to direct someone to repeatedly verbalize,
   e.g. in an interview, that these are their personal views and
   not representative of their City and the rest of Council; and
- s.42 that an ethics commissioner can only be dismissed by 2/3 vote rather than simple majority appears problematic, although there can be a difference between appointment and removal.

# Legal counsel advised:

- Clauses in the Code are not meant to be traps and it is beneficial to include more clauses than less so that it is explicit to all parties;
- In the appointment, suspension or termination of an ethics commissioner, unanimity vote is not a common requirement within existing Codes; and
- The amendments requested are reasonable and can be amended again before adoption.

#### Further discussion ensued regarding:

- Whether the whistleblowing clause is in any currently existing policies and how it could potentially come forward for Council approval and subsequent implementation; and
- Placing a requirement of unanimity in voting may be a serious hindrance for future Councils.

#### MOVED and SECONDED

- **1. THAT** Council approve the Code Conduct Bylaw No. 8408, 2023 for First Reading at the City Council Meeting of June 26, 2023;
- **2. THAT** Council direct staff to commence a search for an Ethics Commissioner; and
- **3. THAT** Council direct staff to bring back a Code of Conduct as amended per the discussion tonight.

All members present voted in favour of the motion.

# 4.2 Additional Public Consultation Events Summary Report: 422 Sixth Street (Circulated Separately)

Discussion ensued:

- Both the in-person and online public engagement sessions were positive events, and Council appreciated being able to talk to residents and business owners not strictly within the bounds of Council procedure;
- Having private security on the site may not be beneficial;
- The legal implications if Council were to make the rezoning or the business licence of the applicant contingent on the Good Neighbour Agreement;
- Drafting the Good Neighbour Agreement to be tied to the applicant's business licence would require a legal review before proceeding;
- Public engagement did not identify security as a concern for the BC Housing project; and
- The amendments would be brought as discussion points with the applicant and staff could report back to Mayor and Council at a future Regular meeting.

**Procedural Note:** A recess was called at 8:12 p.m. and the meeting was brought back to order at 8:25 p.m.

Further discussion continued on:

- Historically, Good Neighbour Agreements have been voluntary;
- If amendments are to be made to the Good Neighbour Agreement, it would indicate a more formalized process, and staff would be required to bring it to the applicant for discussion; and
- Context was provided to Council that Good Neighbour Agreement were originally a policy tool in the 1990s to address dispersal of noise for liquor primary businesses, and currently those requirements are tied with their business licences.

**Procedural note:** A series of amendments were proposed and voted on separately.

#### MOVED and SECONDED

**THAT** Council direct staff to explore the following amendments to the proposed 422 Sixth Street Supportive Housing Good Neighbour Agreement:

 THAT Council amend Section 1 of the 422 Sixth Street Supportive Housing Good Neighbour Agreement by adding: Include 24/7 staffing in place, a certified security guard capable of responding to public concerns, with contact information readily available;

Defeated.

Mayor Johnstone and Councillors Campbell, Henderson and Nakagawa opposed.

During discussion, it was questioned whether a bylaw that addresses extensive policing calls within a neighbourhood exists.

#### MOVED and SECONDED

2. **THAT** Council amend Section 9.b. of the 422 Sixth Street Supportive Housing Good Neighbour Agreement by adding: Quarterly reports to be provided by first responders, police and fire services with respect to the number of calls initiated from or about the property, for a period of 18 months;

Defeated.

Mayor Johnstone and Councillors Campbell, Henderson and Nakagawa opposed.

#### MOVED and SECONDED

 THAT Council add a Section 13 of the 422 Sixth Street Supportive Housing Good Neighbour Agreement: That the business licence of this property to be reviewed, by staff, if there were six or more infractions within a twelve month period;

Defeated.

Mayor Johnstone and Councillors Campbell, Henderson and Nakagawa opposed.

#### MOVED and SECONDED

 THAT Council amend Section 3 of the 422 Sixth Street Supportive Housing Good Neighbour Agreement: That complaints and resolutions be reported out to the Community Advisory Committee and to Mayor and Council upon request;

Defeated.

**WHEREAS** the City of New Westminster has endorsed the Fossil Fuel Non-Proliferation Treaty, has developed the Seven Bold Steps for Climate Action, and has previously opposed the Trans Mountain Pipeline expansion project as an intervenor; and

**WHEREAS** the City of New Westminster has concerns about the impacts to the Fraser River stemming from the pipeline crossing near the Port Mann bridge;

THEREFORE BE IT RESOLVED THAT the City of New Westminster file a Statement of Opposition to the Trans Mountain Pipeline project that is traversing the Fraser River (stalew) to the Canada Energy Regulator website.
