Thank you for taking the time to express your concerns and feedback regarding the proposed project at 808 Royal Av enue. The model of student housing proposed by Douglas College is communal in nature, and students would have a ccess to a number of shared amenity spaces, opportunities for shared and semi-independent accommodation, and su pport from resident advisors (located on each floor) and a resident manager. Among these shared spaces are communal kitchen facilities, located on each student housing floor. These kitchens have been designed to increase socializat ion between students, while reducing food costs. The College has indicated that, consistent with student housing best practices, meal plans would also be provided for students in residence.

To help address your feedback, I would like to provide additional clarity on this development application. Rezoning and Development Permit applications for the proposed student housing and academic building were submitted by Douglas College, which is a public post-secondary institution regulated by Provincial legislation. The role of the City is to evaluate the land use cha nges proposed through these applications, with City Council providing final consideration of the proposed change in z oning. The project would largely be funded by the Province, and operation and management of the building would be t he purview of Douglas College. The proposed model of on-campus student housing, which includes dormitory-styl e accommodation and a community-based living environment, is common across Canada and many successful exam ples can be found throughout the Lower Mainland. The proposed model of housing is compliant with City bylaws and Provincial regulation.
