#### <u>Utility Commission – July 17, 2007</u>

### 2. BC Hydro - Pilot AMI with flex Net (Sensus Metering Systems)

Advanced Metering Infrastructure is a wireless meter reading program which increases efficiency with respect to a combination of utilities. An overview of how the program works will be done in October. A concern regarding this program is, if we go to WiFi, this system is a 900 MHz frequency regulated license by this provider.

# 8. Burnaby Company "Smart Meters"

Rod Carle advised that Hydro will go to RFP for Automatic Meter Reading and Intelligence Systems (Smart Meter technology). This might result in the installation of 1.5 million meters over the next three years. A discussion may be required at a Commission meeting on whether the city should tie in with the scheme and coordinate with Hydro for meter reading and billing. This would depend on whether the system is cost effective. Members indicated that costs and the pros and cons need to be analyzed. Pay back for a conventional automated reader system would be 3 to 3.5 years. A cost benefit would be realized if the city could use our own proposed Wifi system.

# 8. Environment Meeting

Mayor Wayne Wright attended an Environment meeting (GVRD?). At the conclusion of the meeting, the Mayor of North Vancouver discussed smart meters and advised that cities who don't have their own electric utility to look at how New Westminster runs our utility division.

BC Hydro have narrowed it down to three companies with respect to the acquisition of smart meters. Four pilot projects are taking place in different areas.

Fortis BC have applied to BCUC for 100,000 smart meters at a cost of \$33m

(\$100 to \$125 per meter). The General Manager of Electric Utility is in discussion with BC Hydro regarding smart meters.

#### 7. Bill 15- 2008 Utilities Commission Amendment Act, 2008

**CARRIED** 

Page 9, item 11 of Bill. 15 (Utilities *Commission Amendment Act, 2008)* addresses rate rebalancing. Under Section 5, the authority cannot do any rate rebalancing until 2010. After that time, they may revert back to rate rebalancing to a maximum of 2.5 percent. It was also noted that the authority has been mandated to implement smart meters by the end of the 2012 calendar year.

# 4. City of New Westminster Residential Inclining Block (RIB) Rate

The attached BC Hydro graph shows customers annual consumption. The penciled in amount are New Westminster customers. The City Administrator advised that we should get this information out to residents, keep track of any enquiries and have a response document available so

we have a consistent answer for the public if and when they contact the City. General Manager, Mr. Rod Carle, provided the following scenarios:

- 1) Stay as consistent as we can with BC Hydro and have limited variance. Apply the same rate block structure at 1350KWH/2 months and only change the first block **rate**, keeping the same end rate. The only difference from BC Hydro would then be to charge a higher per kwh rate in that first block. In order for us to be revenue neutral we would have to charge .0633/kwh (BCH .0598/kwh).
- 2) Change the block structure to 1000 kwh every two months. End rate would stay the same and change first block rate to .0619/kwh.

#### Additional Factors to Consider

In 2008 BC Hydro and the City implemented an interim rate increase of 6.56% effective April 1st 2008. BC Hydro than continued on with their Revenue Requirement Application (RRA) and because their fiscal year is April to March, filed and applied for rate increases of 6.56% for 2009 and 8.21 % in 2010. Due to up-dated evidence, they re-filed a rate increase of 4.59% increase for 2009 and 8.12% for 2010 which was submitted in October, 2008. At the conclusion of the oral hearing (Nov/08), they have now indicated that they only need 3. 75% for 2009 but need 10.17% increase for 2010. After further review BC Hydro are now recommending to the BCUC to keep 6.56% for 2009 with an increase of 7.50% for 2010. Based on this information, staff recommend to remain status quo with a flat rate until we determine what the BC Hydro increases will be. Revenue application will continue to be monitored. General Manager Mr. Rod Carle advised that Fortis BC applied for smart metering which was denied, they have now been directed to come forward with a conservation RIB rate early in 2009. All Southern Interior Municipal Utilities are currently staying with a flat residential rate until Fortis BC establishes their RIB rate.

## <u>Utility Commission – June 9, 2009</u>

#### 2. Customer Service Performance Stats

For the month of May, Manager, Collection Services Mr. Randy Grant reported that approximately \$200,000 of unpaid utility fees has been

transferred to property taxes. This averages approximately 200 accounts out of 30,000 with an average of \$70.00 per account. Notices are sent to property owners as an electric utility transfer and approximately 50% of owners pay the outstanding amount prior to the fees being transferred to property taxes.

Mr. Grant also reported that the rate rebate has been calculated and will appear on bills as a "credit adjustment". The refund amount will be the difference between 6.65% rate increase and the approved 2.34% increase on consumption between April 1, 2008 and March 31, 2009. This works out to an average refund of \$35.00 per household.

The question arose regarding costs/implications if we went to smart metering. General Manager Mr. Rod Carle stated this would need to be assessed if we wanted to move in that direction. Mr. Carle indicated he has closely been monitoring what BC Hydro are proposing with their Smart Meter Integration (SMI) initiative and once a final proponent has been selected by BC Hydro (3-4 months), Mr. Carle will provide an up-date on SMI to the Commission at that time.
