1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT

Mayor Johnstone opened the meeting at 6:00 p.m. and recognized with respect that New Westminster is on the unceded and unsurrendered land of the Halkomelem speaking peoples. He acknowledged that colonialism has made invisible their histories and connections to the land. He recognized that, as a City, we are learning and building relationships with the people whose lands we are on.

3.1 Train Whistle Cessation – Q3 Update

Discussion ensued regarding the change in the Spruce Street deadline respecting whistle cessation. The crossing is complex and has been progressing with a particular design but a question regarding that design may impact the expected cessation date; staff, in the interest of transparency, indicated the potential need to change the date.

 Arts New West will be maintaining their position as an umbrella organization facilitating arts and cultural events in New Westminster;

- The committee is looking forward to coming together and continuing to guide and update all parties within the arts scene in the City; and
- Consideration around how to include local indigenous representation in terms of business and art within the City.

MOVED and SECONDED

THAT Council endorse the draft Terms of Reference for the Arts, Culture and Economic Development Advisory Committee; and

THAT Council direct staff to proceed with recruitment for the committee.

4.3 Construction Noise Bylaw Exemption Request: 1031 Quebec Street, New Westminster – Metro Vancouver Annacis Water Supply Tunnel, Fraser River Crossing (the "Project")

MOVED and SECONDED

THAT Council hereby grants an exemption to Metro Vancouver contractor Traylor Aecon General Partnership (TAGP) from Construction Noise Bylaw No. 6063, 1992, from October 16, 2023 to December 21, 2023, and from March 1, 2024 to May 31, 2024 on week days from 8 PM to 11 PM and Saturdays from 7 AM to 9 AM and 6 PM to 9 PM, excluding Sundays and Statutory Holidays, to construct the Annacis Water Supply Tunnel, Fraser River Crossing (the "Project").

Adopted on Consent.

4.4 Construction Noise Bylaw Exemption Request: Columbia Street at 8th Street (New Westminster SkyTrain Station)

MOVED and SECONDED

THAT Council grant a noise exemption to TransLink from Construction Noise Bylaw No. 6063, 1992 from 10 PM to 7 AM starting October 31, 2023 to February 28, 2024 including Saturdays and intermittent Sundays, but excluding Statutory Holidays, to demolish and restore original walkways, install new maintenance walkways, and make operational equipment modifications to the New Westminster SkyTrain station.

4.5 Response to February 6, 2023 Special City Council Motion for Utilities Commission Open Minutes Extracts regarding the Advance Metering Infrastructure Project

MOVED and SECONDED

THAT Council receive this report for information.

4.6 Support for TransLink's Bus Rapid Transit Action Plan

MOVED and SECONDED

THAT Council supports in principle TransLink's Bus Rapid Transit Action Plan to advance the provision of fast, reliable, high-quality rapid transit along the Marine Drive/Way corridor from 22nd Street SkyTrain Station to Marine Drive Canada Line Station, and in other priority regional corridors that could reduce regional traffic passing through New Westminster.

THAT Council direct staff to work with TransLink and coordinate with adjacent municipalities towards the planning, design, and implementation of Bus Rapid Transit within New Westminster.

THAT Council ask the Mayors' Council to prioritize the Marine Drive/Way corridor as a priority BRT project, along with other BRT corridors that reduce regional traffic passing through New Westminster.

4.7 Update on Council Motion Regarding "The Right Person, the Right Time, The Right Place"

MOVED and SECONDED

THAT Council direct staff to reach out to the Century House Association to share information related aging in place in New Westminster and to inform the latter of engagement opportunities related to policy, planning and development processes.

THAT Council direct staff to consult with the Century House Association on senior government advocacy with a focus on New Westminster and to report back on specific initiatives and potential financial and staff work program implications.

4.8 Uptown Business Association Business Improvement Association Renewal: 2024 – 2028

THAT renewal of the Uptown Business Improvement Area by Council initiative, at the request of the Uptown Business Association, be commenced:

THAT Uptown Business Improvement Area Bylaw No. 8424, 2023 be forwarded for Council's consideration of three readings; and

THAT staff be directed to proceed with the notice requirements under the *Community Charter*.

4.9 Westminster Pier Park Fire Site – Next Steps

Discussion ensued on the importance of this site being on the Fraser River and how that creates an opportunity for the city and Host Nations to engage in meaningful ways. Council also noted that many in New Westminster share a connection to the river and therefore the park requires additional care in its design and construction.

MOVED and SECONDED

THAT Council receive this report for information; and

THAT Council direct staff to proceed with Next Steps as outlined in this report.

5. OPPORTUNITY FOR THE PUBLIC TO SPEAK TO COUNCIL - 7:00 PM

5.1 Peer Assisted Care Team (PACT) Program Update - Canadian Mental Health Association, BC Division

Jonny Morris, Canadian Mental Health Association, presented on the Peer Assisted Care Team (PACT) program update.

Mr. Morris provided an introduction to PACT and its role in British Columbia – focusing on shifting interactions from health crisis to health

care. He further described common scenarios and typical PACT responses in comparison to police force responses along with data from Metropolitan Police in the UK. The top three reasons to call PACT are assistance requests for those going through a mental health crisis, wellness checks, and substance use-related crises.

Discussion ensued from Council supporting the work PACT is doing, acknowledging that Mr. Morris has been very diligent in pushing for progress in proper care for crises in the community, and giving a reminder that residents in New Westminster can call PACT at 778-727-3909. Mayor and Council noted the importance of the work and creativity behind PACT, a parallel system which frees up police resources.

5.2 Open Delegations

Bob Mackerricher presented on World Polio Day and recounted that in the 1950s, polio was a devastating virus which attacks the nervous system, frequently resulting in death or paralysis. Rotary International has been working to eradicate polio for several decades now.

Council expressed thanks for the work of the Rotaract and Interact Clubs in New Westminster, the importance of such groups to offer a space for members and the additional work they do in the community and around the world.

Mayor Johnstone read the proclamation declaring October 24, 2023, as World Polio Day.

Naomi Perks presented on making New Westminster a safe place for 2SLGBTQIA+ for community members by flying pride flags at civic buildings and adding inclusive recreation opportunities such as 'queer swim' and others.

Council expressed the importance of continuing the work of protecting the rights of this community and speaking up and noting that the community needs more leaders to continue this work. Council looks to such leaders as the delegate presenting to guide the way for all residents of New Westminster and also noted that the City had a well-attended flag-raising at City Hall for Pride Week this year and it is important that community advocates continue to come to such events.

8. MOTIONS FROM MEMBERS OF COUNCIL

8.1 Notices of Motion

a. Amending the City's separation allowance policy to eliminate possibility of 'double dipping' by former Mayors and Councillors

WHEREAS the City of New Westminster compensation package for elected officials includes the payment of a separation allowance upon completion of their term(s) in office equivalent to ten percent of their highest annual remuneration for each year of service commencing after December 1st, 2008 (with a twelve year cap); and

WHEREAS there is no impediment for Council members to receive a separation allowance from New Westminster taxpayers even if they transition successfully into new employment within a short period of time; and

WHEREAS the intent of the separation allowance ought to be limited to bridging the employment gap after a member has ceased to serve on Council;

BE IT RESOLVED THAT Council request legal counsel to draft an amendment to the Council Remuneration Policy such that the separation allowance be set up as a salary continuance for a maximum of 12 months that can be terminated upon a former Council member becoming gainfully employed full-time within the first year after ceasing to serve on Council, rather than as a lump sum payment at the time of separation.
