1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT

Mayor Johnstone called the meeting to order at 6:04 p.m.

Mayor Johnstone recognized with respect that New Westminster is on the unceded and unsurrendered land of the Halkomelem speaking peoples. He acknowledged that colonialism has made invisible their histories and connections to the land. He recognized that, as a City, we are learning and building relationships with the people whose lands we are on.

3. REPORTS AND PRESENTATIONS FOR COUNCIL DISCUSSION AND ACTION

3.1 2023 Point-in-Time Homeless Count: Key Findings and Messages (Information Report from October 16, 2023)

Staff presented on the report which was a snapshot of homelessness in March 2023, which takes place once every three years. This provides a much-needed update particularly with respect to how the COVID pandemic and the opioid epidemic affected the City's homeless count.

Discussion ensued on consideration that solutions need to be specific to the City's local context.

THAT Council receive the report titled 2023 Point-in-Time Homeless Count: Key Findings and Messages for information.

3.2 Responding to the Homelessness, Mental Health and Substance Use Crises: Proposed Two-Year Organizational Pilot Project and Implementation Strategy

Staff presented on background information and context of the three related crises of homelessness, mental health, and substance abuse which included consultation and advocacy, principles, and the framework driving the City's response.

Discussion ensued on:

- The people-centered approach of emergency responders. New Westminster Fire Rescue Services have been performing roles in addition to their fire protection roles;
- Obtaining reliable and relevant metrics which the City can report on to senior governments, with a relevant model city being the City of Victoria; and
- In the context of finding extra costs to be saved in existing services and departments, the City is struggling to keep up with basic core services and there are no efficiencies to be gained.

Procedural note: An amendment was proposed.

THAT Council request staff report back regarding an identified set of targets and intended outcomes as they pertain to the 2-year organizational pilot project and implementation strategy; and

5. OPPORTUNITY FOR THE PUBLIC TO SPEAK TO COUNCIL - 7:00 PM

Mr. Larry Church spoke regarding a confusing agenda on the City's website indicating the meeting tonight is a Public Hearing and led to difficulty in registering for the delegation tonight.

Mr. Church thanked Engineering staff for removing a bike control light at Eighth Street and Seventh Avenue which he noted came after a lengthy time of lobbying. He advised that in July 2023 the City had reduced the minimum distance from a laneway house to the principle house from 16ft to 13ft within the Queen's Park Heritage Conservation Area and requested confirmation. Further, he advised Metro Vancouver Regional District (MVRD) employees had gone into neighbourhoods to review lawn watering compliance contrary to what he believes is a *Community Charter* legislation which authorizes bylaw officers of the local government, rather than the regional district and requested confirmation if City staff supported MVRD employees in this matter.

Staff advised that in July 2023 the City updated guidelines for laneway housing reviews, as part of a streamlining process for housing approval. Regarding lawn watering compliance, staff indicated MVRD does not have bylaw enforcement capacity but instead had employees in an ambassador role to provide information regarding water usage and water restrictions.

- The policy was designed to address the disconnect between elected work and employment afterward.
