1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT

Mayor Johnstone called the meeting to order at 6:00 p.m.

Mayor Johnstone recognized with respect that New Westminster is on the unceded and unsurrendered land of the Halkomelem speaking peoples. He acknowledged that colonialism has made invisible their histories and connections to the land. He recognized that, as a City, we are learning and building relationships with the people whose lands we are on.

2. STATEMENT CONCERNING THE PROPOSED BYLAW AND THE CONDUCT OF THE PUBLIC HEARING

Mayor Johnstone provided a statement regarding the bylaws under consideration, the conduct of the public hearing, and the expected conduct of all participants.

3. <u>Heritage Revitalization Agreement Bylaw No. 8406, 2023 and Heritage</u> Designation Bylaw No. 8407, 2023 for 441 Fader Street

Staff presented on the site's contextual location within Sapperton, the proposal to have a stratified infill house & suite, parking components, heritage elements, design and plan for the infill and heritage house at 441 Fader Street.

Councillor Fontaine joined the meeting at 6:04 p.m.

Thomas Malapitan submitted the proposal and set of plans which included details regarding electrical and telecommunications plans for the dwelling, as well as the tree and arborist report. He noted landscape plans were developed

professionally and considered the ways in which the property would interact with neighbours, such as initiating a shadow study and inclusion of privacy windows.

Julie Schueck presented on the heritage elements of the subject property, the character defining elements and the heritage conservation plan to preserve existing elements into the future.

Lesja Gojda read her letter as submitted to Mayor and Council and the Clerk's Office with respect to concerns of her property having reduced privacy due to the height of the proposed laneway home as well as the proximity and height of the deck and windows. She recognized the City's need for increased density but iterated the need to mitigate the impact of an overscaled house to neighbours in order meet the developer's need to make a profit.

Chris Handford noted his experience in living in the same neighbourhood and regularly sees many historic homes. Noted the proposal's heritage elements would fit in with neighbouring houses.

Mayor Johnstone called for any additional speakers.

Patrick Austin noted the use a two-lot strata for the proposed development and asked who it would benefit. Staff advised stratification is frequently requested as part of HRA applications. Further, a two-lot strata model is something many municipalities currently permit as it is similar to a detached-duplex, unlike commonly existing strata the buildings do not share a wall. Under the new legislation this type of strata is expected to become more common.

Mayor Johnstone called for any additional speakers three times and there were none.

Mayor Johnstone declared a recess at 6:37 p.m.
