**Subject:** Community Advisory Assembly Terms of Reference and Membership

**Update** 

#### **RECOMMENDATION**

THAT Council formally adopt the Terms of Reference for the Community Advisory Assembly, as endorsed by Assembly members and unchanged from the Draft Terms of Reference that were endorsed by Council on August 28, 2023.

THAT Council approve the appointment of three new members to the Assembly, to replace previous members who stepped down or did not attend.

#### **PURPOSE**

To provide updates about the Community Advisory Assembly pilot project, including the Assembly members' endorsement of the draft Terms of Reference and the appointment of three new members following one previous member stepping down and two selected applicants failing to attend the first few Assembly meetings.

### **BACKGROUND**

On August 28, 2023, Council endorsed the draft Terms of Reference for the Community Advisory Assembly, and referred the draft to the Assembly for discussion, feedback and revisions once the group was established. The intent was for the Assembly members to have an opportunity to suggest any changes to the Terms of Reference before they were finalized.

Regarding Assembly member selection and appointment, at Closed meetings in November and December 2023 New Westminster City Council approved the appointment of 36 selected applicants for the new Community Advisory Assembly and directed staff to confirm selected applicants' participation. Member selection was conducted based on the Terms of Reference for the Assembly and followed a "masked" selection based on demographic characteristics of applicants, with names and identifying information removed.

In December, Council further directed that any replacement selections for applicants who failed to join the group should proceed without seeking Council's pre-approval of the names, provided that any replacements be made on the principles of masked selection and choosing an alternate applicant who closely matches the demographic profile of the Assembly applicant who declined to join.

An information report came forward to Council on January 8, 2024 outlining the selection process and the names of the initial 36 confirmed Assembly members. This report is provided as Attachment B.

The Community Advisory Assembly officially got underway in January 2024, with a welcome dinner held January 11 and the group's first working meeting held January 25.

#### **DISCUSSION**

#### **Terms of Reference: Assembly Review Process**

The draft Terms of Reference for the Assembly pilot project were provided to Assembly members in the meeting package for the group's January 25 meeting, and several key aspects of the Terms of Reference were reviewed during the January 25 meeting in a quiz format developed by the Assembly facilitators. Some Q&A and discussion on the Terms of Reference followed. No changes to the Terms of Reference were suggested.

In between the January and February Assembly meetings, members were asked by email to review and provide any additional comments or suggested changes to the draft Terms of Reference. Again, no changes were suggested. At the beginning of the Assembly's second meeting on February 24, the group was again asked to provide any suggested changes to the draft. One Assembly member said they felt the Terms of Reference were well put together. No other comments were shared. The Assembly then unanimously approved the Terms of Reference.

See Attachment A for the final Terms of Reference, which have not changed since Council's review and endorsement in August 2023.

#### **Assembly Member Replacement**

Between member selection and confirmation in December 2023, and the March Assembly meeting (held March 13, 2024), two confirmed members did not attend meetings and one member decided to step down from the group.

These members have now been replaced with other Assembly applicants, based on the same selection process previously followed. The three new confirmed Assembly members are: Ella Durning, Eri MacArthur, and Rosemary Sojka. An updated list of member names is included below.

To select the replacement applicants, staff from two separate departments returned to the spreadsheet of de-identified applicant data and identified alternate applicants with similar demographic characteristics as those who needed to be replaced. In some cases, an exact demographic match was not available among remaining applicants, and an updated demographic breakdown of the group overall is provided below. The names of replacement selections were then provided by staff in a third, separate department.

The Assembly membership also includes substantive representation of recent immigrants, immigrants who arrived in Canada five or more years ago, low-income residents, people living with disabilities, and single parents. Selected members also represent a diversity of racial identities.

- 2. That Council approve the appointment of three new members to the Assembly, to replace previous members who stepped down or did not attend;
- 3. That Council provide alternative direction to staff.

Staff recommend Options 1 and 2.
