PURPOSE

BACKGROUND

Due to administrative oversight, corrections are required in the Riparian Areas Protection Bylaw under the Definitions (Section 2), the Bylaw Notice Enforcement Bylaw (Part 33, Section 3.1(a) and 3.1(b)), and the Municipal Ticket Information Bylaw (Schedule B, Part 33, Section 3.1(a) and 3.1(b)).

DISCUSSION

The changes correct a typographical error and revise bylaw offense descriptions. The associated amendments to Riparian Areas Protection Bylaw No. 7033, 2005, Bylaw Notice Enforcement Bylaw No. 7318, 2009 and Municipal Ticket Information Bylaw No. 8077, 2019 are provided in Attachments 1, 2 and 3, respectively.
