4 CALL TO ODDED IN ODEN SESSION & LAND ACKNOWLEDGEMENT

1. CALL TO ORDER IN OPEN SESSION & LAND ACKNOWLEDGEMENT

Mayor Johnstone called the meeting to order at 6:00 p.m. and recognized with respect that New Westminster is on the unceded and unsurrendered land of the Halkomelem speaking peoples. He acknowledged that colonialism has made invisible their histories and connections to the land. He recognized that, as a City, we are learning and building relationships with the people whose lands we are on.

2. APPROVAL OF THE AGENDA

MOVED and SECONDED

THAT the Council adopt the December 16, 2024 Regular Council Agenda as circulated, with the order of the agenda being varied to consider the items on the Consent Agenda first.

3. <u>REPORTS AND PRESENTATIONS FOR COUNCIL DISCUSSION AND ACTION</u>

3.1 Recommendations on Cultural Observances from the Community Advisory Assembly

With the aid of a PowerPoint presentation (attached to and forming part of these Minutes as Schedule 1), Ella Durning, Maria Nguyen and Juno Avila-Clark, members of the Community Advisory Assembly, presented on the Assembly's findings and recommendations for the City's approach of cultural observances and the following information was noted:

- cultural observances are practices or events based on the traditions, beliefs, and customs of a particular community; they can mark significant religious dates or celebrations, historical events, days of remembrance, seasonal changes and so forth;
- the City does not have an official list of holidays and observances that it recognizes and there are no official policies in place to guide decisionmaking around which observances to mark and at what level;
- the Assembly's input lead to the development of a potential model of three categories for levels of recognition: (i) Category A: City-led events that strengthen a collective identity, (ii) Category B: Community-led observances supported by the City, and (iii) Category C: Awareness raising activities;
- the Assembly then determined how resources should be allocated between the three categories;
- the majority of resources allocated toward cultural observances should be put toward observances that promote a shared community identity and bring people together across differences; and
- it is recommended that approved resources be allocated equally between Categories A and B only.

Discussion ensued regarding the proposed categories and staff were requested to share the Assembly's report with the Arts, Culture and Economic Advisory Committee.

MOVED and SECONDED

 THAT the recommendations on cultural observances from the Community Advisory Assembly, as included in Attachment 1, be received for information.

- THAT staff respond to the Community Advisory Assembly's recommendations on cultural observances, included as Attachment 1 and identify resources required to further develop the Assembly's framework as outlined in the recommendations, and report back to the Assembly and Council in the first half of 2025.
- 3. **THAT** staff prioritize making progress on the Assembly's recommendations in their 2025 work plans.

4.3 Cannabis Store Relocation Requests: North Root Cannabis Ltd. And the Queensborough Cannabis Company

The Chair referenced a letter provided on table from North Root Cannabis Ltd dated December 16, 2024 (attached to and forming part of these Minutes as Schedule 2).

Discussion ensued and the following Council comments were noted:

- the applicants were both successful in the City's past process to rezone limited sites to permit retail cannabis sales;
- the two requests for relocation differ in that one is seeking to relocate to a new area while the other is seeking to relocate within the same area;
- a key consideration in the City's cannabis regulatory framework was to distribute stores across the city, with only one store permitted within each area; and

 in keeping with the spirit of the regulatory framework, it would be prudent to remove the existing permitted use of cannabis retail at the current locations should the proposed relocations proceed.

As a result of the discussion, the following motion was introduced:

- 1. **THAT** North Root Cannabis Ltd. be advised Council would further consider a rezoning application to relocate their operation to another location along East Columbia Street in the Sapperton Neighbourhood;
- 2. **THAT** Queensborough Cannabis Co. be advised Council would further consider a rezoning application to relocate their operation to a location within the Downtown area; and
- 3. **THAT** staff be directed to proceed with the planned review of the Cannabis Regulatory Framework.

The question on the motion was not called as discussion took place on the implication of the proposed relocation requests prior to the review of the Cannabis Regulatory Framework, which is proposed to advance in 2025. Discussion further took place on the removal of the permitted use at the current locations should the proposed relocation applications be successful.

As a result of the discussion, the following amendment was introduced:

5. OPPORTUNITY FOR THE PUBLIC TO SPEAK TO COUNCIL - 7:00 PM

5.1 Massey Theatre's 75th Anniversary

With the aid of a PowerPoint presentation, Peter Leblanc, Chair, Massey Theatre Society accompanied by Avery Halate, highlighted the achievements of the Massey Theatre over the past 75 years.

A. Halate then recounted her experiences performing at the Theatre and commented on the positive connections she has made as a result of her participation in the arts.

5.2 Open Delegations

Alex Misconsiu spoke on environmental impacts of high-rise developments, noting primary construction materials of such projects such as glass, concrete, and steel, contribute to CO2 emissions. A. Misconsiu remarked that the need for additional housing should be balanced with its environmental impacts.

Elliot Rossiter commented on Bill 16, which enables municipalities to develop tenant protection bylaws, noting that there is no requirement for the bylaws to undergo a financial feasibility analysis unlike inclusionary zoning regulations. E. Rossiter then offered policy considerations that support tenant protections.

Karen Crosby spoke in favour of Item 7.1 b. – School Streets Pilot Program, highlighting the numerous benefits of the program for pedestrian safety, health of children, and the environment.

Arley Drew, joined the meeting by videoconference, and remarked that the installation of new bike lanes in the city have limited impact on the cycling community as they do not connect to the remainder of the cycling network.

 Pilot Program that would reflect the principles of the National and/or BC
 Active School Streets Initiative; and
- 3. **THEREFORE BE IT RESOLVED THAT** staff report back on the capital and operating costs associated with the implementation of a School Streets Pilot Program.

The question on the motion was not called as it was noted that the deadline to join the National Active School Streets Initiative has passed. As a result, the following amendment was introduced:
