Subject: Budget 2025: 2025 – 2029 Five Year Financial Plan Bylaw

#### RECOMMENDATION

THAT Five-Year Financial Plan (2025-2029) Bylaw No. 8501, 2025 be introduced and given first, second, and third readings.

#### **PURPOSE**

To request Council give first, second, and third readings to the Five-Year Financial Plan Bylaw for the years 2025 – 2029.

## **DISCUSSION**

On January 13, 2025 Council instructed staff to prepare the consolidated 2025 – 2029 Financial Plan Bylaw reflecting a property tax increase of 6.6% and a multi-year capital budget of \$243.6M for the 2025 fiscal year. The plan incorporates the General Fund and Utility Funds five-year plans including the approved 2025 Water, Sewer, Solid Waste, and Electrical rates.

Attachment 1 presents the City's Five-Year Financial Plan (2025 - 2029) Bylaw No. 8501, 2025 prepared in accordance with Section 165 of the Community Charter. Schedule A to the bylaw provides the consolidated Financial Plan for 2025 through 2029. Schedules B and C provide supplementary detailed information regarding the City's capital program and reserves, respectively.

The Financial Plan has been prepared based on the City's financial policies and budget principles that strive to find a balance between affordability and providing resources to service a growing community for the long term. The plan advances Council's Strategic Priorities and the City's 7 Bold Steps.

### INTERDEPARTMENTAL LIAISON

All City departments participated in the annual budget and financial plan preparation process.

## **CONCLUSION**

Under the provisions of the *Community Charter*, the City is required to adopt a five-year financial plan bylaw prior to May 15<sup>th</sup> each year. It is recommended, therefore, that the 2025 – 2029 Five-Year Financial Plan Bylaw No. 8501, 2025 be considered for three readings.

#### **OPTIONS**

There are two options for Council's consideration:

Option 1 – That Five-Year Financial Plan (2025 – 2029) Bylaw No. 8501, 2025 be introduced and given first, second, and third readings.

Option 2 – That Council provide staff with alternate direction.

Staff recommend Option 1.
