## CORPORATION OF THE CITY OF NEW WESTMINSTER BYLAW NO. 8411, 2025

A Bylaw to Amend Zoning Bylaw No. 6680, 2001

The Council of The Corporation of the City of New Westminster in open meeting assembled ENACTS AS FOLLOWS:

## Citation

1. This Bylaw may be cited for all purposes as "Zoning Bylaw No. 6680, 2001, Amendment Bylaw (805 Boyd Street) No. 8411, 2025."

## **Amendments**

- 2. Zoning Bylaw No. 6680, 2001 is amended by:
  - a. Adding the following as section 120.11.0: "ANIMAL BOARDING means the use of a site for lodging dogs or cats overnight for another person for financial gain."
  - b. Adding the following as section 120.53.2: "DELIVERY AND EXPRESS FACILITY means the use of a building, or portion of a building, as an origin or destination point from which single unit, single axle trucks are dispatched for the local delivery or pick-up of goods, and which may include necessary warehouse space for the transitory storage of such goods. A *Delivery and express facility* also includes a courier service."
  - c. Adding the following as section 543.1.2: "Amusement arcades;"
  - d. Adding the following as section 543.1.3: "Animal boarding;"
  - e. Adding the following as section 543.8.1: "Car washing establishments;"
  - f. Adding the following as section 543.9.1: "Commercial schools;"
  - g. Adding the following as section 543.9.2: "Delivery and express facilities"
  - h. Adding the following as section 543.10.1: "Food and beverage manufacturing"
  - i. Adding the following as section 543.13.1: "Lounge endorsement area;"
  - j. Replacing section 543.25 with the following: "Retail stores;"
  - k. Adding the following as section 543.26.0: "Second hand stores;"

m. Adding a heading entitled "Conditions of Use" after section 543.31, followed by:					
"543.31.1		Food and beverage manufacturing must include a lounge endorsement area, a retail store, or a cafe or restaurant.			
543.31.2	Lounge endorsement area shall only be permitted as an accessory use to food and beverage manufacturing.				
543.31.3	No activities associated with <i>animal boarding</i> , including but not limited to exterior runs, feeding areas, or waste bin storage shall take place within the yards required by this bylaw."
