We understand that the City is currently developing a comprehensive Transportation Plan for the Queensborough Neighborhood to address and enhance the existing transportation network. This plan aims to identify and mitigate traffic congestion, particularly focusing on improving the flow of motor vehicles on current City roadways in Queensborough, including enhancing access to the Queensborough Bridge, which is under the jurisdiction of the provincial Ministry of Transportation and Infrastructure.

SmartCentres is not proposing an increase in the overall density of the existing retail and service space. Instead, we are seeking to diversify the permitted uses on-site to include businesses that will complement and enhance the current offerings. Our objective is to provide local residents with a broader range of shopping and service options conveniently located close to their homes and workplaces, thereby contributing to the community's convenience and reducing the need for longer commutes.

I think it would be good to understand the expected success and viability of these businesses in the community. Many of the existing businesses seem to be struggling. Promotion of alcohol consumption should be cautioned given the known personal and communal health and social implications. Some form of 'compensation' for encouraging this should be implemented. If the goal is to attract more customers to the area then transportation should be a key consideration, especially given the Queensborough area already suffers from bad congestion. More healthy transportation modes (transit, walking, cycling, other non vehicle options) should be built/supported by the developer. Increasing the sites biodiversity, in area and species richness (e.g., native plants), should be a part of making the site better for non-human species and countering the climate implications of more construction and transportation. This could occur in existing unpaved areas, along surrounding edges (river, Boyd Ave, ditches, etc.), or in other areas within Queensborough.

Second, please, please work with Translink to improve transit access to the shopping centre. **S.22(1)** It is a long trek from the ONE closest bus stop just to get to the entrance and then another long hike across a massive desert (I mean parking lot) just to get there. I don't even want to talk about trying to make this journey in the winter! Having a shuttle bus traveling through the shopping centre would provide an option, especially for people with reduced mobility, and would also be a good way to address climate change going forward.
