

Official Community Plan Bylaw No. 7925, 2017, Amendment Bylaw (1084 Tanaka Court) No. 8483, 2024, Zoning Bylaw No. 6680, 2001, Amendment Bylaw (1084 Tanaka Court) No. 8484, 2024

Official Community Plan (OCP) Amendment and Rezoning applications have been received for 1084 Tanaka Court. These applications would change the land use designation and zoning of the site to allow for industrial uses. The site is currently designated and zoned for commercial uses.

In order to allow industrial uses, the applicant proposes to change the zoning from Comprehensive Development District (CD-82) to Light Industrial Districts (M-1). The OCP land use designation is proposed to change from Queensborough Commercial (QC) to Queensborough Mixed Employment (QME).

No form of development is proposed at this time. Future developments would require Development and Building Permits, which could include a variety of light industrial, office, and service commercial uses such as manufacturing, trade schools, self-storage facilities, and more.
