3. PRESENTATION

3.1 Code of Conduct & Respectful Workplace Training

With the aid of a PowerPoint presentation, Jennifer Devins, Ethics Commissioner, provided an overview of Council and the City's responsibilities in accordance with the Code of Conduct Bylaw No. 8408 and the City's Respectful Workplace and Human Rights Policy.

The presentation provided information on the following:

- 1. Why are we here? societal intolerance for bullying and harassment; introduction of broader WorkSafe BC legislation to include bullying and harassment;
- 2. Municipal Governance the role of Council members as fiduciaries and Council's obligation to foster confidence by the general public in the City and its services;
- 3. Respectful Workplaces, Council's Duties duty of employers to meet legal obligations under WorkSafe BC legislation;
- 4. City Policy & Code of Conduct the City's Respectful Workplace and Human Rights Policy applies to all persons associated with and employed by the City and defines various types of harassment and disrespectful behaviour; the Code of Conduct bylaw applies to Council members only and acts as a guide for elected officials to undertake the duties of public office in accordance with sound ethical principles;
- 5. Liability for Bullying and Harassment there is potential corporate and individual legal liability under a number of regulations;
- 6. Cautionary Tales examples of elected local bodies that have demonstrated poor conduct resulting in unhealthy workplaces; and
- 7. Professionalism in the Workplace strategies for defensive management and preventing complaints.
