

BUSINESS REGULATIONS AND LICENSING (RENTAL UNITS) AMENDMENT BYLAW NO. 8525, 2025

Notice is hereby given pursuant to section 59 (2) of the Community Charter, Business Regulations and Licensing (Rental Units) Amendment Bylaw No. 8525, 2025 will be presented to New Westminster City Council for adoption on **Monday**, **June 23**, **2025 at 6:00 p.m.** in the Council Chamber at New Westminster City Hall, 511 Royal Avenue, New Westminster, BC. Per the *Public Health Bylaws Regulation* of the *Community* Charter, Bylaw No. 8525 has been deposited with the Minister of Health and the City has consulted with the local Medical Health Officer (Fraser Health Authority), which has no objections to Bylaw No. 8525.

The purpose of Business Regulations and Licensing (Rental Units) Amendment Bylaw No. 8525 is to prohibit rental building owners from restricting tenants from using a portable device designed to cool internal temperature (air conditioning unit or heat pump) in a rental unit, where air conditioning or another form of cooling system is not installed. Bylaw No. 8525 includes a provision to exempt rental building owners that cannot reasonably comply with the proposed bylaw amendment.
