The City of New Westminster's Fire Protection Bylaw 6940, 2004 requires that a lockbox is installed at all premises where a fire alarm system or an automatic fire sprinkler system are installed. The only lockbox acceptable to the "Authority Having Jurisdiction" per the City of New Westminster's Fire Protection Bylaw (Section 39), is the TRAC-Vault BT Smart lockbox.

3. The selected contractor will drop off the face plate at 1 East 6<sup>th</sup> Ave, New Westminster (Fire Hall 1) so it can be programmed into our system.

4. An inspector will contact you to schedule an appointment to install the faceplate. At this appointment you will need to provide a set of keys for the building that allow Fire Department access to: main entrance, fire alarm panel, fire safety plan, service rooms [sprinkler, hvac, boiler, mechanical, elevator, etc], storage, and any other pertinent areas. **Please ensure your keys are organized and are confirmed to be working.** The inspector will bring the face plate, and provide a set of labeled key chains for your applicable keys.
